## **AFFIDAVIT FOR WARRANT OF ARREST AND DETENTION**

The undersigned Affiant, who after being duly sworn by me, on oath, makes the following statement:

I have good reason to believe and do believe that

### BUEHLER, ANTONIO W/M 6/11/1977

On or about the 1<sup>ST</sup> day of January, 2012, in the incorporated limits of the City of Austin, County of TRAVES and State of Texas, did then and there commit the offense of

### HARASSMENT OF A PUBLIC SERVANT – FELONY 3

ON JANUARY 1, 2012 AT 1:14AM I HAD MADE A TRAFFIC STOP ON A VEHICLE FOR DRIVING "WITHOUT ANY LIGHTS ILLUMINATED DURING THE NIGHT TIME HOURS. I MADE CONTACT WITH THE DRIVER AND NOTICED SEVERAL SIGNS OF INTOXICATION. I DECIDED TO DO A DWI — INVESTIGATION TO DETERMINE IF THE DRIVER WAS SAFE TO CONTINUE DRIVING HER VEHICLE. I HAD THE DRIVER STEP OUT OF HER VEHICLE AND PROCEEDED TO START THE DWI INVESTIGATION. WHILE DOING THE HORIZONTAL GAZE NYSTAGMUS TEST THE PASSENGER IN THE VEHICLE KEPT YELLING OUT THE WINDOW AND INTERFERING WITH THE INVESTIGATION. I SPOKE WITH THE PASSENGER IN THE VEHICLE TWICE AFTER THIS HAPPENED AND WARNED HER NOT TO INTERFERE. SHE WAS EXTREMELY INTOXICATED AT THE TIME. I TOLD THE PASSENGER THAT IF SHE INTERFERED AGAIN THEN SHE WOULD BE PLACED UNDER ARREST. SHE INFORMED ME THAT SHE UNDERSTOOD.

MY BACK UP OFFICER THEN ARRIVED ON SCENE AND I CONTINUED ON WITH THE DWI INVESTIGATION. BEFORE I COULD FINISH THIS INVESTIGATION ON THE DRIVER THE PASSENGER AGAIN STARTED TO INTERRUPT. OFC SNIDER THEN TOLD THE PASSENGER TO GET OUT OF THE VEHICLE AND HE WAS ATTEMPTING TO PLACE HER UNDER ARREST. THE PASSENGER WENT LIMP AND FELL ONTO THE GROUND. I WENT TO ASSIST AND TOGETHER WE WERE ABLE TO STAND HER UP AND PLACE HER INTO HANDCUFFS. WHILE THIS WAS HAPPENING THERE WERE TWO BYSTANDERS THAT WERE WATCHING WHAT WAS GOING ON. ONE MALE WAS BEING VERY VERBALLY AGGRESSIVE. HE WAS IDENTIFIED AS:

#### BUEHLER, ANTONIO

I WENT OVER TO HIM TO ASK HIM TO NOT INTERFERE WITH MY INVESTIGATION. HE BECAME EXTREMELY LOUD AND CONFRONTATIONAL TOWARDS ME. THE TONE OF HIS VOICE WAS EXTREMELY LOUD AND AGGRESSIVE. HE WAS "IN MY FACE" AS I WAS TALKING TO HIM SO I PUT MY HAND ON HIS SHOULDER TO DISTANCE HIM AWAY. I HAD TO RAISE MY VOICE IN ORDER TO TRY AND GAIN COMPLIANCE WITH BUEHLER BUT THIS DID NOT WORK, WHILE I WAS SPEAKING WITH HIM HE SPIT IN MY FACE. I WIPED MY FACE OFF AND THEN TOLD BUEHLER TO PLACE HIS HANDS BEHIND HIS BACK BECAUSE HE WAS NOW UNDER ARREST FOR HARASSMENT OF A PUBLIC SERVANT. HE RESISTED MY EFFORTS TO PUT HIM INTO HANDCUFFS. HE KEPT PULLING HIS HANDS AWAY FROM ME AND I WAS UNABLE TO GAIN CONTROL OF HIM AT THIS TIME, I EVENTUALLY HAD TO TAKE BUEHLER TO THE GROUND SO THAT I COULD BETTER CONTROL HIM. I WAS GIVING HIM LOUD VERBAL COMMANDS TO STOP RESISTING AND TO COMPLY BUT HE KEPT PULLING HIS ARMS AWAY FROM ME TO PREVENT ME FROM PUTTING HIM IN HANDCUFFS. WHILE ON THE GROUND I TOLD HIM SEVERAL TIMES TO PUT HIS HANDS BEHIND HIS BACK BUT HE REFUSED TO DO SO. IT WASN'T UNTIL OFFICER SNIDER TOOK OUT HIS TASER AND THREATENED TO TASE HIM THAT BUEHLER FINALLY COMPLIED AND I WAS ABLE TO PUT HIM INTO HANDCUFFS.
